

BY-LAW NO. 2010 - 65

A by-law of the City of Ottawa to amend By-law No. 2007-268 respecting fees and charges for public transit services.

The Council of the City of Ottawa enacts as follows:

1. Schedule "B", Park and Ride Lots and Associated Fees and Schedule "C", Fares for Transit Services, of By-law No. 2007-268 entitled "A by-law of the City of Ottawa respecting public transit", as amended, are repealed and the Schedule "B", Park and Ride Lots and Associated Fees and Schedule "C", Fares for Transit Services attached hereto are substituted therefor.
2. This by-law shall come into force and take effect on March 1, 2010.
